#### **GENERAL INSTRUCTIONS:**

- 1. The NOTICE OF ADMISSION will be issued at the MWO/Embassy or testing centers.
- 2. Please bring original documents with you for final evaluation and four (4) pieces passport size pictures with name tag.
- 3. Bring the following on examination day:
  - a. Two (2) or more pencils (No. 1 or 2)
  - b. Ballpens with **BLACK ink only**
  - c. One piece long brown envelope
  - d. One piece long transparent/plastic envelope
- 4. Pursuant to Board Resolution No. 25 (s 2019), "Recommending Modifications to Commission Memorandum Circular no. 19 (s 2008): Updated list of non-programmable calculators allowed to be used in the licensure examinations", examinees for the Secondary level, with major in Mathematics, may use calculators during the LEPT, provided, that such calculators have the following features only: addition, subtraction, multiplication, division, trigonometric function, logarithm and xy.

NOTE: ONLY ONE BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.

- 5. The following are STRICTLY PROHIBITED inside the examination premises/rooms:
  - Books, notes, review materials, and other materials containing coded data/ information/ formula;
  - b. For LEPT Elementary Level- ALL KINDS OF CALCULATOR
    For LEPT Secondary Level- ALL KINDS OF CALCULATOR EXCEPT FOR THOSE
    WITH MATHEMATICS MAJOR PURSUANT TO BOARD RESOLUTION NO. 25
    SERIES 2019;
  - c. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES
  - d. Bags of any kind (ladies bags, shoulder bags, attaché case, backpacks, etc.)
  - e. Other examination aids not stated in this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

- 6. Examinees shall follow the health and safety protocols being implemented by the host country.
- 7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.

NOTE: PERSONAL BELONGINGS BROUGHT BY AN EXAMINEE SHALL BE FOR HIS/HER OWN ACCOUNT. THE PRC WILL NOT BE ANSWERABLE FOR ANY SUCH ITEM OR PERSONAL BELONGING THAT MIGHT BE LOST DURING THE EXAM WITHOUT FAULT OR NEGLIGENCE ON ITS PART.
